### What do we know about dog walkers ?



- 25% households have a dog (8 10 million dogs)
- Latest MENE survey shows:
  - 2.85bn visits to the natural environment includes 1.4bn taken with a dog
  - 49-50% of all visits show this level of use
  - Most visits taken close to home -
    - $_{\odot}$  49% less than 1 mile from home
    - $_{\odot}$  27% 1-2 miles from home
    - o 14% 3-5 miles
    - o 10% over 5 miles

# Benefits of dog ownership

- Companionship, joy and fun
- Regular exercise provides for physical and spiritual well-being improves the health of the nation
- Feedback on path conditions and standards, eyes and ears in the countryside
- Provides social interest groups
- Assistance dogs increase mobility and social interaction for owners across a range of disabilities



- Dog walkers go to safe areas for **off-lead** exercise
- Dog walkers want relaxed, trouble free enjoyment
- Often do not know the problems their dog can cause may not be obvious what impact the dog has had e.g. disturbing feeding birds
- Will assume behaviours are ok if they see other dog walkers doing it

### Aims of the campaign



### Results of the 2013 campaign



- 23 press articles,
- 22 schools visited engaging with 6,343 children.
- 361 residents joined GDW increasing the number to 750.
- 24 Fixed Penalty Notices issued.
- 19 Warning Letters issued
- 706 dogs micro-chipped, 41 dogs chip checked.
- 38% increase in reporting of dog fouling
- 90% of residents aware of DCC action to tackle the problem
