## 1. HOW LINCOLNSHIRE & RUTLAND LAFs ARE PRODUCING ROUTES FOR THE DISABLED

#### WHO'S DOING WHAT?

- South Linc's & Rutland LAF joint project with the Mid Linc's LAF
- Discussing countryside access issues with disabled groups
- Identifying suitable routes
- Publishing routes in a similar style to the Lincolnshire County Council Countryside For All Routes.

#### WHAT WE ARE TRYING TO ACHIEVE

- Provide people with information to enable them to make decisions on whether a route is suitable for them.
- To get people out enjoying these routes and benefit from improvements in their health and general wellbeing.
- To give people of all abilities more opportunities to enjoy the countryside

#### WHERE WE ARE DOING IT

- Public Rights of Way
- County Council: Nature reserves

**Country parks** 

- Forestry Commission
- National Nature Reserves
- Wildlife Trust
- Water Companies

#### **THINGS WE HAVE LEARNT**

- The groups we have consulted with are really enthusiastic about Countryside for All routes and are hoping to trial some new routes this year.
- Workload Each site takes 2 person days to survey.
- Changing conditions of the route can effect users (Bourne Wood issues)
- No measure of the number of people with disabilities using the current Countryside For All routes.

2. How you can use the "Let's Get Going!" pack to create routes.

#### HOW WE DO IT

- Create a LAF disability sub group
- Discuss issues with disability groups and sports partnership.
- Identify suitable routes and take account of where disability groups would like to visit and their requirements.
- Teams of two from the sub group survey the site and record the details.
- Produce site plan with relevant information.
- The County Councils produce the information for the printers and place it on their web site.











#### HOW ELSE COULD IT BE CARRIED OUT?

- Include discussions with Physical Activity Development Officers
- Create a group of people who care for each route.
- Deliver Fieldfare Trust training to the relevant people.
- County Council provide the friends of the route with a web site
- Facebook option

#### **FRIENDS OF THE ROUTE**



- Update the friends web site
- Take a major part in the official opening
- Investigate complaints by users e.g. Overhanging branches and take appropriate action.
- Undertake user surveys
- Responsible for providing the County Council with details of any permanent changes to the route

#### **HOW SHOULD WE PROMOTE THE ROUTES?**

- Press release to community papers, parish councils and organisations for the disabled.
- Leaflets to doctors surgeries
- Leaflets to hospital waiting areas
- Route experience days
- Further press releases as new routes become available.

#### <u>Get Out, Get Moving, Get Fit & Enjoy The</u> <u>Countryside For Free</u>

The people of Leicestershire are creating countryside routes for people of <u>ALL ABILITIES</u> to access and enjoy. The routes are listed and fully described at www.....

If you do not have access to a computer your library will be able to assist.

The routes display pictures, angles of any slope, descriptions of surface conditions, location of parking for the disabled, location of disabled toilets and points of interest.

The routes are provided and managed by a number of different organisations in Leicestershire . The routes are cared for by a group of friends of the specific site.



- Collect ideas from all major countryside owners
- Collect ideas throughout GB
- Get Natural England to assist in delivering the project



- Get the English Tourist Board involved
- Get Visit Britain onboard
- This is what a group of us are aiming to do!



#### WHAT WOULD THAT WORLD LOOK LIKE?



- Standardised method of measuring & displaying Countryside For All sites UK wide.
- Only sites which adopt that form of measurement can display the Countryside For All accreditation
- One stop web site where all Countryside For All accredited sites can be found
- There are already web sites which could do this.



#### NATURAL ENGLAND'S WEB SITE

- Costs of maintaining this web site and loading site details are small
  - Web hosting £179.88/pa.
  - Loading individual site details £2.50
    - Costs supplied by Natural England via Freedom of Information (2013)

- Anyone can upload a route
- Uploaded routes checked by Fieldfare
- Could display web address to "friends of route"
