AGRICULTURAL LAND CLASSIFICATION REPORT

Medway Towns Local Plan, Site 23: Wainscott

INTRODUCTION

- 1. This report presents the findings of a detailed Agricultural Land Classification (ALC) survey of approximately 7 ha of land on the eastern side of the district of Wainscott, Rochester in Kent. The site is bounded to the east and north by main roads, the A228 and A289 respectively, and to the west by the built up development of Wainscott. The southern boundary of the site comprises a footpath across which is a school and associated playing fields. The survey was carried out in February 1996.
- 2. The survey was commissioned by the Ministry of Agriculture, Fisheries and Food (MAFF) Land Use Planning Unit, Reading in connection with the Medway Towns Local Plan. This survey supersedes any previous ALC surveys on this land.
- 3. The work was carried out under sub-contracting arrangements by NA Duncan & Associates and was supervised by members of the Resource Planning Team in the Guildford Statutory Group of ADAS. The land has been graded in accordance with the published MAFF ALC guidelines and criteria (MAFF, 1988). A description of the ALC grades and subgrades is given in Appendix I.
- 4. At the time of survey the majority of the site was in set-aside following a cereal crop. A small area at the south western corner of the site comprises an area of former allotment gardens, which are currently overgrown and derelict.

SUMMARY

- 5. The findings of the survey are shown on the enclosed ALC map. The map has been drawn at a scale of 1:10,000; it is accurate at this scale but any enlargement would be misleading.
- 6. The fieldwork was conducted at an average density of one auger boring per hectare. A total of 8 borings and 1 soil pit was described.
- 7. The whole site (7.1 ha) has been classified as Grade 2, very good quality agricultural land. The area comprises free draining, fine silty soils overlying stony fine loamy deposits at depth. The major limitation associated with this land soil droughtiness.

FACTORS INFLUENCING ALC GRADE

Climate

8. Climate affects the grading of land through the assessment of an overall climatic limitation and also through interactions with soil characteristics.

9. The key climatic variables used for grading this site are given in Table 2 and were obtained from the published 5km grid datasets using the standard interpolation procedures (Met. Office, 1989).

- 10. The climatic criteria are considered first when classifying land as climate can be overriding in the sense that severe limitations will restrict land to low grades irrespective of favourable site or soil conditions.
- 11. The main parameters used in the assessment of an overall climatic limitation are average annual rainfall (AAR), as a measure of overall wetness, and accumulated temperature (AT0, January to June), as a measure of the relative warmth of a locality.
- 12. The combination of rainfall and temperature at this site mean that the area is relatively dry and warm. The site is not considered to be exposed or subject to any particular frost risk and as such no climatic limitation exists on this site.

Site

13. The site lies at an altitude of approximately 10 m AOD and falls very gently to the east, with gradients in the range of 0-1°. The site is not prone to flooding and consequently site factors do not impose any limitation to the quality of the land.

Geology and soils

- 14. The published geological information (BGS, 1977) shows the site to comprise Head Brickearth overlying Thanet Beds.
- 15. There is no detailed published soil map for this district but the reconnaissance soil survey map (SSEW, 1983) has mapped the site area as Urban due to the limitation of scale. The adjoining land however is mapped as Fyfield 4 association. Fyfield 4 soils are described as 'deep, well drained often stoneless coarse loamy and sandy soils, with some fine loamy soils with slowly permeable subsoils and slight seasonal waterlogging and some slowly permeable seasonally waterlogged fine loamy over clayey soils' (SSEW, 1983).

AGRICULTURAL LAND CLASSIFICATION

- 16. The details of the classification of the site are shown on the attached ALC map.
- 17. The location of the auger borings and pits is shown on the attached sample location map and the details of the soils data are presented in Appendix III.

Grade 2

18. The whole site has been classified as Grade 2, very good quality agricultural land. The area comprises free draining fine silty soils overlying stony, fine loamy deposits at depth. A typical profile on the site has a medium silty clay loam or fine sandy loam topsoil over a brown, stoneless medium silty clay loam subsoil with a coarse subangular blocky structure. Stony (c.20% flints) heavy clay loam horizons were encountered below 70-80 cm depth in some profiles although this did not impede drainage or root extension. The major limitation associated with this land therefore is a minor droughtiness restriction, and moisture balance calculations indicate that in this low rainfall area these soils will be slightly droughty for both 'reference' crops, restricting the land quality to Grade 2.

APPENDIX I

DESCRIPTIONS OF THE GRADES AND SUBGRADES

Grade 1: Excellent Quality Agricultural Land

Land with no or very minor limitations to agricultural use. A very wide range of agricultural and horticultural crops can be grown and commonly includes top fruit, soft fruit, salad crops and winter harvested vegetables. Yields are high and less variable than on land of lower quality.

Grade 2: Very Good Quality Agricultural Land

Land with minor limitations which affect crop yield, cultivations or harvesting. A wide range of agricultural or horticultural crops can usually be grown but on some land of this grade there may be reduced flexibility due to difficulties with the production of the more demanding crops such as winter harvested vegetables and arable root crops. The level of yield is generally high but may be lower or more variable than Grade 1 land.

Grade 3: Good to Moderate Quality Land

Land with moderate limitations which affect the choice of crops, the timing and type of cultivation, harvesting or the level of yield. When more demanding crops are grown, yields are generally lower or more variable than on land in Grades 1 and 2.

Subgrade 3a: Good Quality Agricultural Land

Land capable of consistently producing moderate to high yields of a narrow range of arable crops, especially cereals, or moderate yields of a wide range of crops including cereals, grass, oilseed rape, potatoes, sugar beet and the less demanding horticultural crops.

Subgrade 3b: Moderate Quality Agricultural Land

Land capable of producing moderate yields of a narrow range of crops, principally cereals and grass, or lower yields of a wider range of crops or high yields of grass which can be grazed or harvested over most of the year.

Grade 4: Poor Quality Agricultural Land

Land with severe limitations which significantly restrict the range of crops and/or the level of yields. It is mainly suited to grass with occasional arable crops (e.g. cereals and forage crops) the yields of which are variable. In moist climates, yields of grass may be moderate to high but there may be difficulties in utilisation. The grade also includes very droughty arable land.

Grade 5: Very Poor Quality Agricultural Land

Land with severe limitations which restrict use to permanent pasture or rough grazing, except for occasional pioneer forage crops.

APPENDIX II

SOIL WETNESS CLASSIFICATION

Definitions of Soil Wetness Classes

Soil wetness is classified according to the depth and duration of waterlogging in the soil profile. Six soil wetness classes are identified and are defined in the table below.

Wetness Class	Duration of waterlogging ¹
I	The soil profile is not wet within 70 cm depth for more than 30 days in most years. ²
П	The soil profile is wet within 70 cm depth for 31-90 days in most years or, if there is no slowly permeable layer within 80 cm depth, it is wet within 70 cm for more than 90 days, but only wet within 40 cm depth for 30 days in most years.
Ш	The soil profile is wet within 70 cm depth for 91-180 days in most years or, if there is no slowly permeable layer present within 80 cm depth, it is wet within 70 cm for more than 180 days, but only wet within 40 cm depth for between 31-90 days in most years.
IV	The soil profile is wet within 70 cm depth for more than 180 days but not wet within 40 cm depth for more than 210 days in most years or, if there is no slowly permeable layer present within 80 cm depth, it is wet within 40 cm depth for 91-210 days in most years.
V	The soil profile is wet within 40 cm depth for 211-335 days in most years.
VI	The soil profile is wet within 40 cm depth for more than 335 days in most years.

Assessment of Wetness Class

Soils have been allocated to wetness classes by the interpretation of soil profile characteristics and climatic factors using the methodology described in Agricultural Land Classification of England and Wales: Revised guidelines and criteria for grading the quality of agricultural land (MAFF, 1988).

¹ The number of days is not necessarily a continuous period.

² 'In most years' is defined as more than 10 out of 20 years.

- 14. CALC: If the soil horizon is calcareous, a 'Y' will appear in this column.
