Best practice study - 'opportunity' maps for landscape scale conservation of biodiversity

Introduction

English Nature is aware of a number of approaches which have aimed to deliver biodiversity, on a landscape scale, by the restoration, re-creation and creation of BAP habitat. These approaches might be described as "opportunity maps" : the term "nature map" or "ecological network" is also used. In particular a number of projects have focused on producing maps which set out where habitats should / could be created. English Nature is interested in the concept and how it might be applied at a range of spatial scales from national to local .

What was done

An analysis of the generic issues surrounding "opportunity map" products was undertaken in connunction with the developers of the maps, their partners and using peer reviews :

- what was the motivation to produce the map(s) in the first instance ?
- how these maps made available ?
- the ownership of the map and reaction to it (positive and negative) within the environmental groups and in the wider world ?
- the scope of the map and whether or not only environmental dimensions were taken on board ?
- how successful was the subsequent use of the map as a means of influencing policy and delivery on the ground ?

Results and conclusions

A table summarising where all (40) known opportunity maps have been produced on a district, county or regional scale in England. The table will contain links to images of the maps and provide links to, or at least references to material which is available.

A short list of up to 8 maps / products, to be studied to address best practice and the key issues analysis arising from the development and use of the product.

Examination of how such maps fit with existing strategies such as BAP, Local (Development) Plans, regional planning guidance, agri environment targeting, and how different methodologies can be matched and note the outstanding issues which have limited the uptake or use of the product.

English Nature's viewpoint

This is an existing and emerging area of work which has implications not only for the delivery of BAP but also how conservation measures can be delivered in the context of other drivers and issues. The work is particularly relevant as it can provide guidance to organisations contemplating developing such maps. It is relevant to the promulgation of an ABD approach and is also significant in terms of the way Natural England might address nature conservation, landscape and land management issues.
